

ARTICLES OF AMENDMENT

EFFECTIVE 96 1 3 0 THE NORTH CAROLINA FORESTRY FOUNDATION, INCORPORASE RETARY OF STATE

Pursuant to § 55A-10-05 of the General Statutes of North Carolina, the undersigned corporation (the "Corporation") hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation:

- The name of the Corporation is: The North Carolina Forestry Foundation, Incorporated.
- A new paragraph 9 is added to the Articles of Incorporation which reads as follows:
 - "9. Except to the extent that the North Carolina General Statutes prohibit such limitation or elimination of liability of Directors for breaches of duty, no Director of the Corporation shall have any personal liability arising out of an action whether by or in the right of the Corporation or otherwise for monetary damages for breach of any duty as a Director. No amendment to or repeal of this paragraph 9 shall apply to or have any effect on the liability or alleged liability of any Director of the Corporation for or with respect to any acts or omissions of such Director occurring prior to such amendment or repeal. The provisions of this paragraph 9 shall not be deemed to limit or preclude indemnification of a Director by the Corporation for any liability that has not been eliminated by the provisions of this paragraph."
- The date of adoption of the amendments was 4-26-96 1996.
- Each amendment was duly adopted by a sufficient vote of the Board of Directors without member approval. Member approval was not required because no members have voting rights.
 - These articles will be effective upon filing. 5.

ARTICLES OF AMENDMENT

OF

CERTIFICATE OF INCORPORATION OF

THE NORTH CAROLINA FORESTRY FOUNDATION, INCORPORATED

For the purpose of effecting an amendment to its

Certificate of Incorporation, pursuant to the provisions of

Chapter 55A of the General Statutes of North Carolina, North

Carolina Forestry Foundation, Incorporated states as follows:

- 1. The name of the corporation is THE NORTH CAROLINA FORESTRY FOUNDATION, INCORPORATED.
- 2. The Certificate of Incorporation of the corporation is hereby amended as follows:
- (a) Paragraph 3 of the Certificate of Incorporation is amended by deleting the words "The North Carolina State College of Agriculture and Engineering of the University of North Carolina" wherever the same shall appear therein and substituting in lieu thereof the words "North Carolina State University at Raleigh."
- (b) A new Paragraph shall be added to the Certificate of Incorporation which shall be entitled Paragraph 8, and which shall read as follows:
- "8. Notwithstanding any other provision of this certificate, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section

501(c)(3) of the Internal Revenue Code and its
Regulations as they now exist or as they may hereafter be amended, or by an organization contributions
to which are deductible under Section 170(c)(2) of such
Code and Regulations as they now exist or as they may
hereafter be amended.

"The corporation shall have no power to declare dividends, and no part of its net earnings shall enure to the benefit of any member or director of the corporation or to any other private shareholder or individual. The corporation shall have no power or authority to engage in activities which consist of carrying on propaganda or otherwise attempting to influence legislation or to participate in, or intervene in, any political campaign on behalf of any candidate for public office.

"In the event of the dissolution of the corporation, either voluntary or involuntary, all assets and property which remain after the discharge of the corporation's libilities shall be paid over or distributed by the Board of Directors to the School of Forest Resources of North Carolina State University at Raleigh, and shall be used or distributed for no other object or purpose whatsoever.

"This corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute; provided, however, that under no circumstances shall these Articles of Incorporation be amended so that the corporation may

operate other than exclusively for religious, charitable, scientific, literary or educational purposes, or so that any member or director or any other private individual may participate in the distribution of the earnings, funds or properties of this corporation."

3. This amendment was adopted by the Board of Directors of the corporation at a meeting held on the last day of foresteen law, 1970; on said date a quorum of the Directors was present at such meeting; and such amendment was unanimously adopted by the members of the Board of Directors present at such meeting. (No members have voting rights.)

RESOLUTION OF DIRECTORS

NORTH CAROLINA The Board of Directors of the North Carolina Forestry Foundation, Inco; a corporation of North Carolina, on this 19 day of May, A.D., 1966, do hereby resolve and declare that it is advisable that Sections 2 and 3(a) of the Certificate of Incorporation of April 15, 1929, and the preamble of the Certificate of Amendment of June 11, 1947, be amended.

Section 2, of the original Charter reads as follows:

2. The location of the principal office of the corporation in this State is _____ Professional Building, West Hargett Street, in the City of Raleigh, County of Wake, but it may have one or more branch offices and places of business out of the State of North Carolina as well as in said State.

The preamble of the amendment of 1947 reads as follows:

The location of the principal office in this State is at No. 301 Ricks Hall in the City of Raleigh County Wake.

The name of the agent therein and in charge thereof, upon whom process against this corporation may be served, is J. V. Hofmann, Secretary-Treasurer.

Section 3(a) as amended in 1947 reads as follows:

- 3. The objects for which this corporation is formed are as follows:
- (a) To acquire by purchase, lease, option, deed of gift, or otherwise, lands to be devoted to the specific objects and purposes particularly set out in this paragraph in order to aid and promote by financial assistance and otherwise all types of forest education and

research at, or by, the Division of Forestry of North Carolina State College of the University of North Carolina at Raleigh, North Carolina.

CERTIFICATE OF CHANGE

The North Carolina Forestry Foundation, Inc., a corporation of North Carolina, doth hereby certify that pursuant to said resolution, and upon notice duly given to all directors, as provided by law and the by-laws of this corporation, a meeting of the directors was held at the time and place specified, and more than two-thirds of the directors of said corporation having voting powers being represented in person or by proxy, a resolution was unanimously adopted approving the amendment proposed by the Board of Directors, as follows:

2. The location of the registered office of the corporation in this State is in the Foundation office building, in the Community of Deepe, County of Onslow, but it may have one or more branch offices and places of business out of the State of North Carolina as well as in said State.

The agent therein and in charge thereof, upon whom process against this corporation may be served, is G. E. Jackson, Manager, or in event of a change of managers by the Board of Directors, his successors.

- 3. The objects for which this corporation is formed are as follows:
- (a) To acquire by purchase, lease, option, deed of gift, or otherwise, lands to be devoted to the specific objects and purposes particularly set out in this paragraph in order to aid and promote by financial assistance and otherwise all types of forest education and research at, or by, the School of Forestry, North Carolina State University, at Raleigh, North Carolina.

THE NORTH CAROLINA FORESTRY FOUNDATION, INCOMPORATOR

THIS IS TO CERTIFY, that we, the undersigned, do hereby associate ourselves into a non-stock corporation under and by virtue of the laws of the State of North Carolina, as contained in Chapter 22 of the Consolidated Statutes, entitled "Corporations", and the several amendments thereto, and to that end do hereby set forth:

- The name of this corporation is THE NORTH CAROLINA FORESTRY FOUNDATION, INC." shall be considered to be a sufficient expression and signature of such name for all proper purposes.
- 2. The location of the principal office of the corporation in this state is _____ Professional Building, West Hargett Street, in the City of Raleigh, County of Wake, but it may have one or more branch offices and places of business out of the state of North Carolina as well as in said state.
- The objects for which this corporation is formed are as follows:-
- (a) To acquire by purchase, lease, option, deed of gift, or otherwise, lands to be devoted to the specific objects and purposes particularly set out in this paragraph, or for the furtherance of such objects or purposes or any of them, or to arrange for the furtherance of such objects by placing such lands under the control of competent agencies interested in forestry as an agency of the public welfare.
- (b) To promote the production and preservation of growing timber for experimental, demonstration, educational, park and protection purposes.
- (c) To encourage, by demonstration and publicity, the adoption of means and methods for the improvement and the preservation of growing timber.
- (d) To encourage, by demonstration, experiment, publicity, and improved forestry methods, the adoption of means and methods for the re-

forestation of cut-over timber lands and other lands upon which the timber growth has become depleted.

- (e) To hold suitable tracts of virgin timber as object lessons in forestry.
- (f) To open up such tracts of land as may be acquired for the education of the public and to permit the use of such tracts or parts thereof as public parks, at such times and for such periods as may be determined by the Board of Directors.
- (g) To cut, saw, trim, repair, remove or otherwise use any trees growing, lying or being upon any lands acquired by purchase, lease or otherwise, which may be deemed necessary or advisable in carrying out any or all the purposes and objects of this corporation.
- (h) To encourage the donation of money and the making of gifts to the corporation to enable it to further carry out its objects and purposes.

And in order to properly prosecute the objects and purposes above set forth, the corporation shall have full power and authority to purchase, lease or otherwise acquire, hold, mortgage, convey and otherwise dispose of all kinds of property, both real and personal, both in this state and in all other states, territories and dependencies of the United States; to construct, equip and maintain buildings, works, factories and plants; to install, maintain and operate all kinds of machinery and appliances; to operate same by hand, steam, water, electric or other motive power, and generally to perform all acts which may be deemed necessary or expedient for the proper and successful prosecution of the objects and purposes for which the corporation is create
