Public Records and PRRs

- https://policies.ncsu.edu/
 - 33 policies/regulations revised
 - 3 new regulations
 - 3 regulations repealed
- Public Records Requests
 - FY19-20: 220 requests last year
 - FY20-21: 279 requests this year
- Creation and maintenance of records
- Records retention and disposition schedule
- Electronic records management



Ethics, Governance, and Board of Trustees

- State Ethics Liaison: Allison Newhart
 - Monitor all gift and lobbying restrictions
 - State ethics training and disclosures
- Conflicts of interest and commitment
- Board governance issues
- Trustee legal questions
- Open meetings laws and process



Athletics & OGC: Significant Collaboration

 <u>Alston v. NCAA</u>: In June 2021, the U.S. Supreme Court ruled that the NCAA may not limit education-related benefits that institutions provide to student athletes

 Name, Image, Likeness (NIL): NCAA rules changed on July 1, 2021
